#### ABOUT WOMEN LAWYERS' ASSOCIATION OF SA INC

The Women Lawyers' Association of South Australia Inc (WLA/'the Association') is a professional association that represents the interests of women legal practitioners across South Australia. The Association is an affiliate of the national branch of Women Lawyers' and its Committee meets once a month at the Law Society of South Australia. The SA branch of the Association runs fundraising events for charity as well as making representations to parliament and other bodies on issues that impact upon the status of women in the law and society. The Association also fosters networking amongst women members of the profession.

Membership of the Association is open to all practitioners and law students who wish to further the interests of women under the law and women legal practitioners in South Australia.

The following is a synopsis of the key activities undertaken by the Association:

- WLA is regularly consulted on the appointment of senior counsel and the judiciary in South Australia.
- WLA writes submissions on proposed law reform(s) which affect women and impact upon the broader justice arena.
- WLA organises regular social and networking events, to provide women with legal backgrounds and women practising in the profession the opportunity to develop valuable contacts and meet like minded professionals.
- WLA has an important educational objective and regularly organises career seminars and information sessions for law students and junior solicitors.

#### **OUR OBJECTIVES**

The Women Lawyers' Association of SA Inc. (WLA/ 'the Association') is the South Australian branch of the Australian Women Lawyers Association (AWL) and was founded with a number of objectives in mind.

These objectives include:

- achieve justice and equality for all women
- further the understanding of, and support for, the legal rights of women
- identify, highlight and eradicate discrimination against women inherent in the legal system
- identify, highlight and eradicate discrimination against women in the community generally
- advance equality for women in the legal profession

In July this year WLA hosted its first ever Quiz Night at the Hungarian Club Norwood which was a huge success and raised several thousand dollars for our nominated charity this year; NUNGA MIMNAR. Well done to the organising Committee.

Our next function will be held in October 2010 to welcome the five women barristers who have been called to the Bar this year. Keep a look out on our website for more information about this event.

#### Consultation

WLA again participated in consultation with the Chief Justice regarding the appointment of Senior Counsel.

Through AWL, we continue to provide feedback to the Commonwealth Attorney-General about appointments to Federal Courts, tribunals and statutory positions.

For the first time in 2010, the President met with the State Attorney-General to discuss the work of WLA and policy issues of concern to us. WLA was also consulted regarding appointments to State Superior Courts. In the lead-up to the State election, the President met with the Shadow Attorney-General and corresponded with the Leader of the Opposition.

Our various submissions to government over the years and appearance at the national parliamentary inquiry finally came to fruition with the passage of legislation to introduce tax-payer-funded paid parental leave at the Federal minimum wage. Joining with other women's groups who have lobbied for this change for decades, WLA wishes to emphasis the fundamental importance of the scheme, the introduction of which was overshadowed by other political developments. WLA will continue to advocate for improvements to paid parental leave including extending the term beyond the current 18 weeks, addressing the question of continuity of superannuation contributions, and changing the means-test to "total family income" rather than focusing on the mother's income (which unfairly discriminates against professional women who are the main bread-winners in their families).

#### **Australian Women Lawyers**

Australian Women Lawyers (AWL) had a full and exciting year under the leadership of President Olivia Perkiss of the Queensland Bar. I served as Vice President, but having completed four years on the board, stepped down at this year's AGM and will be replaced by Amy Challans. The incoming AWL President is Mary Anne Ryan from Tasmania.

AWL's major projects this year included the 2009 Gender Appearance Survey, conducted by Eliquent and funded by the Law Council, which measured the rate at which women advocates appear in Australian superior courts. This has resulted in the Law Council producing an "Action Plan" to address the low rate of participation of women as barristers (19% of the Bar nationally), and the type and length of matters in which they are briefed (shorter matters, less likely to be briefed by private firms). AWL also ran (with the assistance of Lexis Nexis) its third national conference in Brisbane in August 2010 which was well attended and attracted a very high caliber of presenters. With the benefit of a scholarship funded by our Patron, WLA was able to send junior lawyer Kristina Piper as a delegate to the AWL conference.

#### **Changes to WLA Administration**

Congratulations to Ilona and Amy for bringing the Association's financial and administrative affairs (respectively) into the 21st century. We now have the ability to use internet banking, Pay Pal (including credit card payments) and conduct most transactions via our website. Amy has also been collating pro forma documentation and attending to the updating of our website.

Please ensure that if you change your email address, you provide WLA with your new details. To save on postage and paper, we communicate with members exclusively via email.

The Committee determined in 2009 to publish an annual report in lieu of the previous *Boardroom & Bench* newsletter. We welcome feedback regarding this change and encourage any member who wishes to contribute articles or photographs to do so.

#### **Weddings and Babies**

Be wary of drinking the water at Committee meetings!! Congratulations to our brides Taruna, Christina and Shelley and also to Christina and former Committee member Anne Barnett who will both be new mums (again, in Anne's case) by the time this report goes to print.

#### The Challenges Ahead

In last year's report, I wrote about pay equity, retention and promotion of women to senior positions within the profession and flexible work practices. Like paid parental leave, these are not goals we can realistically expect to achieve overnight, they require sustained and continued action by us and our likeminded male colleagues. Sometimes I am frustrated by the slow pace of progress.

This year, I want to highlight the struggles faced by the newest members of our profession; recently admitted graduate lawyers, over half of whom are women. With three law schools now teaching in Adelaide (and UniSA is yet to produce a graduating class) and the increased popularity of law as the "new arts degree", more new lawyers than ever are entering the profession. Admission ceremonies, once held only one or two times per year, are conducted back-to-back to cater for the number of graduates. However, for those wishing to work as lawyers, there are only so many employment opportunities, especially in Adelaide.

Of course, economic ups and downs and the ebb and flow of legal work in certain fields have always created periods when either employee solicitors or firms had the upper hand. But with hundreds and hundreds of applications for every clerkship, graduate position or government contract I cannot remember a time when it was more difficult for new lawyers to find a job.

This has led some unscrupulous employers to take advantage of the desire of graduates to gain practical experience by offering long periods of unpaid "work experience". To those who offer short term, meaningful and well supervised placements – I salute you. To those employers who are using unpaid, unsupervised (and often uninsured) labour - do not kid yourself, it amounts to exploitation and brings our profession into disrepute. Confusion about the changes to Commonwealth employment laws and the status of the State Salaried Lawyers Award has also lead to instances of underpayment of junior lawyers. Those concerned are often so thankful to have a job at all they are extremely reluctant to complain.

Members and friends, whether you are an employer or a more senior employee with the courage to stand up for your junior colleagues, please ensure that we do the right thing by the most vulnerable in our profession.

If you are in a position where you make recruitment decisions, you certainly have difficult choices to make with so many well qualified graduates. No doubt there will frequently be little which separates one candidate from another. Consider hiring the person who doesn't have a single relative in the law, who has no connection to the partners or to

an important client. She may have ("only") a Distinction average rather than straight HDs, didn't do a clerkship at a top-tier national firm in the uni holidays or work as a volunteer for UNHCR in a war-zone refugee camp. On the flip side, she might have useful life and workplace skills gleaned during, or before, law school and the ability to juggle exams, assignments, tutorials and paid work with family responsibilities. Oh, and she might turn out to be a brilliant lawyer if she can just get her foot in the door!

Karla McCulloch Treasurer of WLA has indicated that she will not seek re election as Treasurer and will retire from the Committee.

## **GOVERNANCE STATEMENT**

#### Introduction

Women Lawyers Association of SA Inc. ('WLA/ the Association') is incorporated under the Associations Incorporated Act (SA) 1995. The business and affairs of WLA are overseen and controlled by a Committee ('the Committee'). The Committee comprises of WLA members elected to office bearer positions, namely, president, vice-president, treasurer, Secretary and eight other WLA members elected as general members of the Committee.

WLA is governed with integrity and in a responsible and accountable manner. The Committee is dedicated in their approach to work continuously to meet the objectives of the Association and to implement strategies in pursuit of excellence and providing the best membership value.

The Committee meets at least twelve times a year for the purposes of overseeing all aspects WLA's business plan, its objectives and values. Additionally, the Committee reviews its performance by measuring the outcomes of its events and yearly actions against its annual business plan objectives and ensuring compliance with any legal requirements.

Twelve meetings of the Committee were held during the period 1 September 2009 -30 August 2010.

#### **Members Role**

The Constitution of WLA requires that a meeting of full members known as the Annual General Meeting ('AGM') is to be held annually; refer to section 4.7 of the WLA Constitution.

The purpose of the AGM is to:

- To confirm the minutes of the preceding Annual General Meeting
- To receive the President's report for the previous financial year
- To receive the Treasurer's report and the financial statements for the previous financial year
- To elect or re-elect the Office Bearers and Committee Members who must consent in person or in writing
- To conduct any other business placed on the agenda before the commencement of the meeting

All Full (voting) members of WLA are advised in advance of the AGM in accordance with the requirements of the Constitution. This notice includes notice of retirements from the Committee and nominations for the election or reelection of office bearers. The notice for this year's AGM was distributed to all members via e-mail on 19 August 2010

WLA Committee encourages all members to attend the AGM.

#### **Committee Composition**

The names and details of all Committee members in office up to 30 August 2010 are set out in this annual report.

The composition of the Committee reflects the broad range of experience, skills and knowledge required to oversee the running of WLA, its business and affairs.

The Committee is responsible for wide variety of matters including succession planning.

#### **Sub Committees**

To assist in the execution of its responsibilities, the Committee has established a number of sub-Committees. These sub-Committees operate on a needs basis to fulfill a number of diverse roles.

#### These roles include:

- To provide specialist knowledge to the Committee on a certain matter(s)
- To review and/or advise the Committee on legislation, policy, best practice
- To organise specific social events
- To manage certain projects outlined in the business plan
- To make recommendations to the Committee on a range of matters

#### **Membership Sub Committee**

This sub Committee is responsible for reviewing WLA's current membership policies including membership benefits and services. It is envisioned that this sub Committee will have a large role to play in the 2010 -2011 year with increased focus by the WLA Committee its membership in the coming year.

# **Australian Women Lawyers National Conference**



"Justice for All" was the theme of the third annual Australian Women Lawyers (AWL) National Conference held in Brisbane in August. AWL is primarily concerned with issues relating to the advancement of women in the legal profession and access to justice issues for women in the community. It works to eliminate both direct and indirect discrimination against women in the legal system and in the administration of justice so that the legal system is more responsive to women's needs.

Keynote speakers at the conference covered issues relating to family violence, the financial sector and the long-term effects of the Global Financial Crisis, gender discrimination and access to justice, the state of the profession, and law and policy reform.

Delegates were privileged to hear many distinguished speakers and for me, highlights were addresses by The Chief Justice of the Family Court, the Hon Diana Bryant; Tasmanian barrister Mary-Anne Ryan; the Hon Justice Jane Mathews AO from the Supreme Court of NSW; and the Queensland Attorney General the Hon Cameron Dick MP.

Chief Justice Bryant spoke about the process of ADR within the Family Court system and pointed out that many clients who have been bullied in an abusive relationship may feel they have been bullied into accepting terms of an agreement. There was a suggestion that a "cooling off period" for the clients would allow them time to reflect away from the presence of the abusive partner, and to ask if the agreement really is in the best interests of themselves and their children. Also, it was suggested that some ADR facilitators may want an agreement reached as they have target numbers of successfully negotiated agreements to reach.

Mary-Anne Ryan presented some worrying statistics from the ALRC Family Violence inquiry. One study showed that out of 11 partner murders where the deceased was a victim of domestic violence, only two perpetrators were previously known to the police.

Gender discrimination and its effect on access to justice were discussed by the Hon Jane Mathews from NSW. She said critics had noted that laws and the legal system were primarily constructed by males, which is reflected in the adversarial system. With only 18% of barristers in NSW being female, the state is currently conducting surveys to source why this number is so low, with the aim of removing the barriers that may be holding women back.

The Hon Cameron Dick's address on his role was especially interesting. He spoke of a recent Bill that amended the Queensland Criminal Code to insert a new partial defence to murder of "killing in an abusive relationship", available in addition to the existing defences of provocation and self-defence. For the defence to apply, the accused will have to prove they had been in an abusive domestic relationship and the person they killed had committed acts of serious domestic violence against them. The Queensland Attorney-General said he was implementing new projects and initiatives, reviewing state Acts and working to improve opportunities for women lawyers in the state.

The social program included Governor-General Ms Quentin Bryce AC launching the book *Women and the Law in Australia*. She gave a talk which was both informative and entertaining and afterwards, to our delight, mingled with the delegates.

I would strongly encourage all women lawyers to attend the next conference - to be held in Canberra in 2012 - and to promote it with colleagues, peers and associates. Apart from the great networking opportunity and a fun time, the conference promotes the interests of the AWL and, more generally, of women in the legal profession.

## HONORARY LIFE MEMBERS

# **Robyn Layton**



Justice Robyn Layton graduated from the University of Adelaide in 1967 and was admitted to the bar in 1968. After ten years as a practitioner in private practice with the Honourable Elliott Johnston AO QC, she was appointed at a young age as a Judge and Deputy President of the South Australian Industrial Court and Commission where she served for seven years, and then sat as a Deputy President of the Administrative Appeals Tribunal for four years. The Honourable Ms Layton QC then returned to practice at the independent Bar from Murray Chambers and took silk in 1992. She completed a Master's Degree in 1999 and was appointed a Justice of the Supreme Court of South Australia in 2005.

Early on, Ms Layton QC was the South Australian Counsel for Civil Liberties and was appointed as a solicitor for the Central Aboriginal Land Council. She was also Chair of the South Australian Sex Discrimination Board and later chaired the Human Rights Committee of the Law Society of South Australia. She is currently a patron of the Migrant Resource Centre of South Australia.

In 2003 she was commissioned to produce a comprehensive review and government plan for the protection of children, entitled "*Our Best Investment*". She was been a Member and Chair of the Committee of Experts for the United Nations' International Labour Organization in Geneva for over 15 years, which subsequently led her to involvement in judicial and legal practitioner education and training, both in Australia and in various international venues in Europe and Asia.

Ms Layton QC, Chairs the Advisory Committee for the Australian Centre for Child Protection. She has also served on various boards and corporations such as the South Australian State Theatre and the South Australian Art Gallery, the National Bioethics Consultative Committee, the Health Insurance Commission and was a Director of the National Rail Corporation.

Her retirement from the Supreme Court of South Australia became effective 3 September 2010 and she now intends to pursue her interest in international judicial education. She was recently appointed an adjunct Professor of the School of Law at the University of South Australia.

Ms Layton QC is the mother of two adult daughters, both of whom are lawyers. We wish Robyn well in her retirement!

# **Margaret Nyland**



Justice Margaret Nyland was appointed a Justice of the Supreme Court of South Australia on 15 October 1993. She is the Chairperson for the Law Foundation of South Australia and Patron of WLA SA.

# **Christine Trenorden**



Judge Christine Trenorden, of the District Court of South Australia and the senior judge of the Environment, Resources and Development Court, was appointed in 1993 and retired on the 10 September 2010. Her Honour was also a Presiding Member of the Equal Opportunity Tribunal of South Australia and chaired the Community Relations Committee of the State Courts Administration Council, which has responsibility for drafting and implementing, the Courts' Community Involvement Plan. She chaired the South Australian chapter of the Australian Institute of Judicial Administration and has been extensively involved in education and professional development in the area of environment and planning law.
